MINISTER'S REPORT – 2018



I would like to start by thanking the entire Pastoral Charge for being so kind and gracious as you accepted me and my family. From the beginning we have felt welcomed and included, and that means a great deal to me. Your hospitality and openness are helping to heal the wounds of the past. I feel very welcomed and comfortable as your Pastor.

Over the last five months I have enjoyed getting to know you and your families. Being a Christian community is clearly something you take very seriously, and you are an asset to the area. Everyone works very hard and gives their time generously in every aspect of the church's life. You put on the best dinners I have seen anywhere in Churchland!

As I arrived in September instead of mid-summer, I had to hit the ground running, and in many ways the fall was a "baptism by fire". As mentioned last year, we discontinued our activities at Country View Lodge in Pakenham. Throughout 2018 the residents were successively moved to other facilities in Eastern Ontario. As of December 2018, the Lodge was officially closed.

Over the course of 2018 we sent out nearly fifty cards to members of the two congregations. These cards were primarily to extend sympathy or thinking of you or get well wishes but occasionally to acknowledge a special event or a milestone birthday. In addition to the cards, two members of the team invested their time by making approximately forty personal home or hospital visits to members of both congregations. If you are aware of anyone deserving special contact, please advise any member of the Team.

Members of the team met informally throughout November to prepare for the Advent and Christmastime effort for members of both congregations, particularly for those confined to their own home, a nursing home, a retirement home or a hospital. These selections of seasonal delights were delivered by a member of the Team; accompanied by a visit when possible.

Unfortunately, but expected, 2018 was a year of loss for family and friends of both congregations. With Pastor Bill's guidance we produced a 2018 version of the *"Thinking of You at Christmas"* Order of Service for families coping with the pain of losing a loved one during the past year. These were delivered personally by Pastor Bill where possible.

MINISTRY AND PERSONNEL REPORT - 2018

The Ministry and Personnel committee was comprised of Denzel Ferguson and Rosser Lloyd from Zion and Dave Wilson and myself from St Andrew.

With the appointment of Bill Checkley as new minister on September 1, 2018, the M&P committee will assume a greater role in supervision and support of the minister. Bill has been appointed to a .75 position a SME candidate. The first step has been to establish a 12-month calendar based on the optimal use of the allotted hours for a .75 position. The starting point will be the monthly calendar developed when the pastoral charged decided to move to a .75 minister. The next steps will be to work with "Future of the Church" committee to develop a number of innovative ways to free up Bill to devote more time to outreach and pastoral care.

The M&P committee is still in the process of conducting performance reviews with all salaried employees, in order to complete the mandate for 2018. Salary increases will be offered to all employees in order to keep up with increases in the cost of living.

After my two year as chair of the M&P committee, I will be stepping down. The chair should now be assumed by a member from Zion. I will continue as a member of the committee.

2018 was the final year of meetings for Upper Valley Presbytery. Some of the highlights were: The Annual Meeting of Bay of Quinte Conference which was held in Napanee April 26-29th. Gayle and I were both able to attend. Susan DeHaan became chair in June making Bronwen Past Chair.

The tri-annual meeting of General Council which was held in Oshawa from July 21-28th. Bronwen attended as a delegate from Bay of Quinte Conference. We made a renewed commitment to the work of responding to the work of the Truth and Reconciliation Commission by passing recommendations from our United Church Indigenous Leaders for the way forward. Our representation will remain as in the past- each congregation will have a representative to the regional council.

ZION TRUSTEES REPORT - 2018

Zion Trustees continued to monitor the long-term investments that originated from the sale of the manse. As of December 31, 2018, the market value of the investments was \$96,337.78. While this is up from the balance of \$78,695.46 a year earlier, it includes \$20,000 transferred into the account from the Church's term investments in March, 2018. The transfer was approved by the congregation at the February Annual Meeting in an effort to improve returns on the Church's investments. There were no funds withdrawn from the long-term investments to meet the operating costs of the Church in 2018, as offerings and other income were sufficient to cover the costs. This will continue to be monitored with the Committee of Stewards each year.

Recognizing the \$20,000 investment into the account, the difficult year experienced by all investors in the market resulted in a loss of \$2,357.68 from the January 1, 2018 balance. This compares to the \$6,319.03 in gains in 2017.

On May 24 the retirement of Rev. Jeff de Jonge was celebrated with a joint service and picnic at the Cedar Hill Tree Farm. Jeff humbly accepted the accolades and congratulations from the two congregations. We all wish Jeff much happiness and fulfillment as he moves on with the next phase of his life journey.

The hard work of the Joint Search Committee resulted in the appointment Bill Checkley as the next pastor of the Pakenham Pastoral Charge. Bill was hired under the Supervised Ministry Education program. He was officially welcomed to the pastoral charge at his Covenanting Service on December 2.
